- Develop, implement, and monitor IEPs for each qualifying student.
- Develop and maintain a classroom/therapy environment conducive to effective learning.
- Establish and maintain open lines of communication with students and their parents/guardian concerning both the academic, behavioral, and therapeutic progress of all assigned students.
- Collaborate with other staff members to meet the holistic needs of assigned students and in planning and implementing the instructional goals, objectives, and methods.
- Evaluate and write evaluation reports and IEPs for each student upon referral and continuously throughout their program.
- Maintain accurate, complete records as required by law, District policy, and administrative regulations.
- Perform screenings for OT services.
- Maintain lists and schedules of referred, screened, and eligible students receiving therapy or other school provided OT services.
- Deliver services that are billable to MO HealthNet and keep adequate records to support the billing process.
- Fulfill any OT services district subcontracts to other districts and entities.
- Other duties as assigned and/or prescribed by Maryville R-II School District policies and procedures.
